



2026 OUTSTANDING FULL-TIME FACULTY MEMBER AWARD

*The Illinois Community College Trustees Association's **OUTSTANDING FULL-TIME FACULTY MEMBER AWARD** recognizes the high achievement of Illinois' community college instructors.*

AWARD CRITERIA

Each nomination for the ICCTA Outstanding Full-Time Faculty Member Award will be reviewed according to the following criteria:

- In what ways has this educator demonstrated excellence in teaching?
- What has this educator initiated and helped to develop in the area of innovative programs used in two-year postsecondary institutions?
- How has this educator served on technical or special committees that have positively affected the community, state, or nation?
- How has this educator provided leadership in helping to solve challenges facing two-year postsecondary institutions?
- How has this educator been active in developing, organizing, or supporting state and/or national two-year postsecondary education associations?
- What awards or honors has this educator received in recognition of leadership in the college or community?

NOMINATION REQUIREMENTS

Nominations for the ICCTA Outstanding Full-Time Faculty Member Award must be submitted by the board of trustees of an ICCTA member college. Each ICCTA member college is eligible to nominate one full-time faculty member per year. **Posthumous nominations are not eligible for submission.**

In order for a nomination to be considered, all of the following items must be included in the nomination packet.

The total length must not exceed six (6) single-sided pages:

- Letter of support from the college board of trustees
- Responses to each of the above award criteria questions
- Self-statement of 250 words or less describing the nominee's philosophy of education
- Optional supplemental materials (i.e., resumé, news articles, brochures, photos)

In addition, the nomination must include a narrative statement (not to exceed 150 words) that explains the nominee's qualifications and is suitable for use in ICCTA publicity materials. *The narrative statement is not included in the 6-page nomination packet, but it is required for a nomination to be considered.*

★ Failure to follow these guidelines will result in the disqualification of a nomination ★

Because the names of many deserving nominees are received each year, boards of trustees are encouraged to **re-submit** the names and qualifications of former nominees for consideration.

PROGRAM DEADLINES

All nomination materials must be received **BY 5 PM, FRIDAY, MARCH 27, 2026. THIS DEADLINE WILL BE STRICTLY ENFORCED.** All award nominees will be invited to attend ICCTA's June 5, 2026 awards banquet in Lombard, where the statewide winner will be announced.
