The ICCTA Board of Representatives took the following actions at its March 18, 2006 meeting at the Embassy Suites Chicago O'Hare Hotel in Rosemont, Illinois:

- Welcomed comments from Noah Brown, president/CEO of the Association of Community College Trustees, and Judy Erwin, executive director of the Illinois Board of Higher Education;
- Previewed ICCTA's March 29 Lobby Day. Trustees will focus on the following key issues:
 - 1) **SUPPORT** the Governor's proposed FY07 budget, which includes a **1.9% increase** for community colleges;
 - 2) SUPPORT additional funding for Illinois Veterans Grants and Disadvantaged Student Success Grants; and
 - OPPOSE the sale of the Illinois Student Assistance Commission's student loan portfolio;
- Approved the association's FY07 budget, which includes <u>no dues increase</u> for the fourth year in a row;
- Accepted the ICCTA Nominating Committee's proposed slate of officers for 2006-2007:
 - * Kathy Wessel (DuPage) Vice president
 - * Jerry Wright (Illinois Central) Treasurer
