ICCTA Board Highlights

Notes from the ICCTA Board of Representatives' March 11-12, 2022, meetings, held in person and virtually via Zoom at the Holiday Inn and Suites in East Peoria, Illinois.

ADVOCACY

- Received copies of ICCTA's <u>Fact Sheet on Gov. Pritzker's proposed Fiscal Year 2023 community college budget</u> and the ICCTA/Illinois Council of Community College Presidents' <u>joint statement supporting Gov. Pritzker's FY23 budget</u>;
- Called attention to a letter sent to lawmakers by ICCTA, the Presidents Council, and the Illinois Public University Presidents and Chancellors Group that emphasizes the importance of collective negotiations at the local level;
- Learned that ICCTA is developing a fact sheet about the expanded Statements of Economic Interest now required by Public Act 102-0664;
- Encouraged trustees to participate in ICCTA's "Back Home Lobbying" initiative. The ICCTA region that meets with the most state legislators this spring will be recognized during the association's June 10-11 annual convention in Chicago;
- Proposed that Illinois community colleges consider forming a rural

consortium to seek \$5 million in <u>federal Career, Technical, and</u> <u>Education equity grants</u>;

- Heard an update on ICCTA's work on community college baccalaureate degrees. College presidents have been asked to assist in compiling local workforce data to help build a persuasive case for CCB degrees in Illinois; and
- Acknowledged ICCTA's March 11 luncheon speaker Dr. Rita Ali, the first woman and first person of color to serve as mayor of Peoria. Prior to her election as mayor, Dr. Ali served as vice president of workforce and diversity at Illinois Central College.

MEMBER ENGAGEMENT

- Adopted an <u>Anti-Racism Statement</u> based on the University of Redlands Anti-Racism Statement;
- Announced that the application deadline for 2022-2023 ICCTA office (vice president, secretary, or treasurer) is 5 PM, Monday, April 18. In-person interviews will be held Friday, April 29, in Springfield, with elections occurring at the June 11 annual meeting in Chicago;
- Were alerted that April is National Community College Month (#CCMonth). ACCT's 2022 Community College Month toolkit is now available online, and Gov. Pritzker has proclaimed April 2022 as Illinois Community College Month;
- Thanked the Illinois Community College System Foundation for its donation of \$500 each for ICCTA's 2022 Paul Simon Student Essay Contest and Gregg Chadwick Student Service Scholarship;
- Learned that ICCTA's March 11 Trustee Roundtable discussed recent enrollment trends and strategies, how colleges are dealing with employee fatigue, and campus security issues;
- Noted that ICCTA's March 11 seminar offered an excellent review of college finances from a statewide and local campus perspective;



ICCTA received high marks for its March 11 educational seminar on Community College Financial Literacy.

- Were informed that ICCTA's upcoming seminars will focus on creativity and unconventional strategies in community colleges (April 29) and minority contracting (June 10). Future sessions may cover campus housing and free community college;
- Learned that ICCTA's ad hoc Dues Committee is examining various formulas to modernize the association's dues structure;
- Heard updates from the Presidents Council, ACCT, and the Illinois Community College Board; and
- Acknowledged the in-person and virtual participation of the following colleges in ICCTA's March 11-12 activities: Black Hawk, Danville, DuPage, Elgin, Harper, Heartland, Highland, Illinois Central, Illinois Valley, Joliet, Kankakee, Kaskaskia, Kishwaukee, Lake County, Lake Land, Lewis and Clark, Lincoln Land, Malcolm X, McHenry, Moraine Valley, Oakton, Parkland, Richland, Rock Valley, Sandburg, Sauk Valley, Southeastern, Southwestern, and Spoon River.
