ICCTA Board Highlights

Notes from the ICCTA Board of Representatives' March 10-11, 2023, meetings, held at the Westin Chicago Lombard Hotel in Lombard, Illinois.

ADVOCACY

- Received an update on the Illinois General Assembly's spring 2023 session. The <u>Governor's Fiscal Year 2024</u> <u>budget proposal</u> includes a 7% increase in community college funding, boosted by higher-than-anticipated revenue estimates;
- Discussed a possible expansion of <u>Illinois Public Act 94-1006</u> to create a Lifelong Learning Account program for healthcare workers;
- Were briefed on ICCTA's research on community college baccalaureate degrees. Based on data gathered through the association's Joyce Foundation grant, legislation may be introduced next year to establish pilot CCB programs in Illinois;
- Asked the ICCTA Awards Committee to begin drafting guidelines and criteria for a proposed Future of Work and Society Scholarship for Illinois community college students; and

• Learned that ICCTA has been invited to host a University of Chicago intern for summer 2023. The internship will focus on trustee demographic research & CCB.

TRUSTEE EDUCATION

Adopted a resolution encouraging member colleges to utilize the Association of Community College
Trustees' <u>Diversity</u>, <u>Equity</u>, <u>and Inclusion Checklist and Implementation Guide for Community College Boards</u>,
or another tool or guide deemed appropriate by their board, to monitor their institution's progress with DEI
and report their findings to their board on an annual basis;

- Heard that ICCTA's March 10 Trustee Roundtable discussed dual credit and dual enrollment issues in depth. Due to high interest, the association will sponsor a seminar on this topic at its September 2023 meeting;
- Noted that ICCTA's March 10 seminar offered an excellent introduction to competency-based education, featuring presenters from the Illinois Community College Board, Lewis and Clark Community College, and Parkland College;
- Were informed that ICCTA's June 2-3 annual conference will provide trustee leadership development training as required by Illinois Public Act 99-692; and
- Received reports from ICCB, ACCT, and the Illinois Council of Community College Presidents.

MEMBER ENGAGEMENT

- Announced that the application deadline for 2023-2024 ICCTA office (vice president, secretary, or treasurer) is 5 PM, Friday, April 28. In-person interviews will be held Tuesday, May 2, in Springfield, with elections occurring at the June 3 annual meeting in Bloomington/Normal;
- Learned that ICCTA's ad hoc Dues Committee is proposing a \$60,000 cap on a member institution's annual dues. Related ICCTA Bylaws/Operations Manual changes will be on the agenda for the association's May 2 board meeting; and
- Acknowledged the longtime board tenure of two retiring trustees: John Duffy of Elgin Community College (48 years of service) and Richard Roehrkasse of Southwestern Illinois College (32 years of service).
