ICCTA Board Highlights

November 18, 2020

The ICCTA Board of Representatives took the following actions at its November 14, 2020 meeting, held via telephone and Zoom videoconference:

 Adopted ICCTA's <u>2021 Legislative Goals</u>, which include a special focus on equity on higher education;



- Analyzed the results of the November 3 general election. Failure of the graduated income tax amendment
 will place tremendous pressure on the state's finances. Gov. Pritzker has asked state agencies to trim their
 budgets by 5 percent to fill a potential \$4 billion shortfall over the next two fiscal years. The Illinois
 community college system could see 5-8 percent cuts;
- Learned that COVID-19 concerns have led to cancellation of the Illinois General Assembly's fall 2020 veto session and modification of the February 2021 <u>Community College National Legislative Summit</u> to a virtual format;
- Shared ideas on how to reach out to lawmakers remotely, such as inviting them to serve as guest lecturers, appear at virtual town halls, and participate in Zoom issue briefings;
- Heard that the Illinois Community College Board plans to offer a webinar on enrollment strategies, in response to the system's 13.7 percent drop in fall 2020 enrollment;
- Received positive feedback on ICCTA's November 13 seminar on diversity, equity, and inclusion, which
 featured presentations by State Rep. Chris Welch and representatives of Illinois Central College, the
 Association of Community College Trustees, and the Illinois Department of Human Rights;
- Thanked local boards for hosting <u>ICCTA's "road show" award presentations</u>, which are taking place around the state in lieu of the association's June 2020 awards banquet;
- Learned that trustees may soon be appointed to the ICCB board and the <u>Illinois Board of Higher Education's</u>

 <u>Strategic Planning Advisory Committee</u>;
- Were informed that the Illinois Community College Marketing Collaborative has selected a consultant to develop a statewide media campaign for fall 2021;
- Reported that Trustee Roundtable participants shared 1) how their colleges are responding to possible budget reductions following the failure of the "Fair Tax" amendment, and 2) how colleges responding to the COVID-19 pandemic;
- Approved several "housekeeping" amendments to the ICCTA Bylaws and Operations Manual;
- Discussed possible non-dues revenue sources, including the addition of a job-posting page on the ICCTA website;
- Noted the November 11 passing of Dr. Jerry Weber, former president of Kankakee Community College and the College of Lake County; and
- Expressed a 'season of thanks' to trustees, presidents, and other community college advocates for the work they do for their students and higher education. Happy Thanksgiving!
