

QUICK SURVEY RESULTS Board Retreats

September 21, 2023

A total of 24 colleges/districts responded to ICCTA's Quick Survey on BOARD RETREATS.

HIGHLIGHTS:

- 42% of responding colleges hold board retreats annually, while 12.5% hold retreats three or more times a year.
- The president participates in board retreats at nearly every college.
- Other retreat participants include the president's executive assistant, the board attorney, and top administrators.
- **❖** More than 70% of board retreats take place on campus.
- A majority of board retreats are facilitated by an outside consultant (most often ICCTA staff).

1. Does your college a board retreat? If YES, how often?

• Waubonsee: Waubonsee has not been holding board retreats on a regular basis. There was a board retreat

that was held in two parts, in April and May of 2022 (the second date was a continuation of one of the topics, and discussed in greater detail); however, I don't recall any other board retreats

prior to that date.

Spoon River: President; Assistant to the President; and President's Cabinet members

4. If YES to Question #1, what topics are discussed?

• Danville: One focuses on finances, another features boardsmanship with a facilitator, a third one involves

strategic planning, and the fourth annual retreat is dedicated to evaluating the president as well

as the trustees evaluating their performance collectively as a board.

• DuPage: Board governance, updates on College initiatives that are too long to be done at a regular board

meeting

• Elgin: Varies each year, depending on newly elected trustees; specific events such as accreditation

and strategic plan preparation

• Harper: January - considered the Financial Workshop to begin discussions about tuition for the following

year

March - a topic related to the Strategic Plan; we have been focusing on discussions about

closing achievement gaps and the student experience

July - review of the final budget status for the previous fiscal year, risk management initiatives, technology, facility needs, Board and President's goals for the following year (topics vary based

on current initiatives)

Heartland: Strategic Planning, Goals, End Statements

Highland: A wide variety of topics depending on upcoming items that will be before the board for action in

the future that are not of a routine nature. We also have a division report from one of our deans during each retreat and administrative updates from the VPs on items such as the budget, new

legislation affecting community colleges, etc.

• Illinois Valley: This past one was my first--but I am seeing this as more of a conversation-based model, not

action items. For the first one, we talked about the relationship between the Board and the

President, I gave my VP's the chance to present, and had more of a conversation.

• Joliet: Board Development

• Kankakee: Strategic planning and annual review of strengths, weaknesses, opportunities and threats

• Kaskaskia: Year in review, strategic plan updates, ancillary plan updates, any restructure if necessary, and

SWOT analysis

Lake County: Board Governing Principles, Board efficiency and effectiveness, alignment and becoming a high

performing board, issue discussion, president/board relations, role of president and role of

board, policy governance

• Lewis and Clark: Budget planning; Preview of Strategic Plan; Board Survey; Board Governance, Goals, and

Expectations: Board Advocacy

• Logan: We use ICCTA to guide the topics

Morton: Institutional goals/strategic planning/board evaluation

Oakton: Strategic priorities for the College; Board self assessment

• Parkland: Strengths, weaknesses, things to start, stop, and continue, goals, health of the board.

Richland: Strategic Planning, Budgets, Community Events

Rock Valley: Varies

Sauk Valley: A bunch

• South Suburban: Board Responsibilities, ICCTA updates, HLC and specialized accreditation updates, capital

improvement updates, other topics recommended by the Board to name a few topics.

Standard topics for Board Retreats include updates from President's Cabinet members on: Spoon River:

> Facilities and Operations; Organizational Updates; Academics; Student Services; Finance; Board Policy review; and State law changes. Additional topics are addressed based on input

from the Trustees when establishing and building the agenda for the Retreat.

• Triton: Board Self-Evaluation, current topics

Additional comments:

 Danville: The four retreats typically correspond with the seasons, like Vivaldi -- finance in winter, boardsmanship

in the fall, president/board evaluations in the spring, and strategic planning usually (but not always) in

the summer.

Harper: We refer to these sessions as workshops rather than retreats.

· Kaskaskia: In my experience, they have been an invaluable way to share information and to educate new BOT

members on the processes of the College, as well as an opportunity to network outside of a regularly

scheduled BOT meeting.
