COMMENTS

Harper: Harper College will include Decennial Committee meetings as part of regularly scheduled

Committee Meetings of the Whole on October 18, 2023, February 14, 2024, and May 8, 2024.

These meeting dates have been identified because they include regularly scheduled

discussion topics related to the budget.

A separate notice for the Decennial Committee will be posted and noted on the posted agenda

for the Committee Meeting of the Whole.

A draft agenda is currently under review and will be provided to ICCTA when finalized.

Highland: We have not had our first meeting yet, but we plan to hold the first meeting one hour before

our regular August meeting. No agenda has not been set at this time.

• Illinois Valley: We have chosen to meet directly prior to our meeting and will post accordingly. Our first

meeting is not until September -- so I do not have a notice prepared yet.

• Kishwaukee: We are in the planning stages, and have just approved our committee membership.

• Lake County: According to the legislation, "at least a majority of the members of the committee are present

at the committee's meeting. Each meeting of the committee shall be public..." As such, if the decennial committee is scheduled as a separate meeting, then it would seem that we have to

have a separate public notice. We are clarifying with our legal counsel.

• Lake Land: Robbins Schwartz provided excellent guidance (FAQ's document) on what we must do to

comply with the Decennial Committee on Local Government Efficiency Law.

• Lewis and Clark: We have not started this yet. Would love to hear what everyone else is doing.

Rock Valley: Rock Valley College will hold our Decennial Committee meetings as separate meetings, but

beginning immediately before our regular board meetings, so trustees do not have to make a separate trip to campus. Our first meeting will be June 27, so we have not yet prepared the

public notice.

• Shawnee: As you are likely aware, the legislation requires a final report to be shared with each County

Board in our District. Further, the legislation states, "...the committee <u>may</u>, if required, provide the <u>same report</u> to the county board of each of those counties." At this point in the process, we intend to approach the project as if the same report can be delivered to all five Counties we serve. That is, we are hoping the efficiencies identified are consistent through-out our

District and are relevant for each County Board.
